Simply authorize Federal Land Bank Association of Hawaii, FLCA or Hawaii Production Credit Association to directly debit your checking or savings account on or about the first of the month and you'll never worry again about mailing your check on time. You will continue to receive a copy of your billing statement in the mail.

If you decide later that you would prefer to pay your loan payments directly to the association, you can terminate ACH by writing to the association.

For ACH convenience, simply complete the form on the reverse side, attach a voided check from your financial institution (for verification), and return it today. Be sure to make an extra copy for your records.

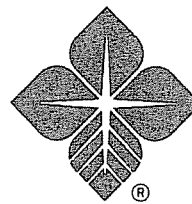
